### **Owners Agreement:**

1. I understand all board and/or training fees must be paid monthly in advance. Failure to comply or removal of horse without payment of any accrued balance shall constitute a breach of contract and an automatic lien on the horse in favor of All Stars Arabians, LLC.:
2. I agree that before removing horse (s) from All Stars Arabians payment must be made in full by cash, cashier's check or credit card.
3. This horse, to the best of my knowledge, has not been exposed to any contagious or infectious disease for two weeks prior to arrival at All Stars Arabians.
4. I hereby consent to any medical treatment for my horse deemed advisable in any emergency.
5. I consent to any medical treatment for my horse deemed advisable by North All Stars Arabians or their veterinarian. I understand I will be responsible for paying these charges.
6. Every precaution is taken to protect the horse from illness, accident, fire or theft. All Stars Arabians and/or its agents and/or employees shall not be held liable for any loss or injury from illness, accident,

fire, or theft, here at the farm, during hauling to or from an event (show exhibition, etc.) or at any event (show, exhibition, etc.).

7. I understand that any lessons, showing, shoeing, veterinary service, shipping and miscellaneous expenses are additional costs and shall be billed accordingly. I agree to pay all additional costs in full upon presentation of billing and prior to the horse's departure.

8. I further agree that in the event that my account with All Stars Arabians becomes delinquent and the farm deems it necessary to turn this matter over to any attorney for collection, I will be responsible for, in addition to the outstanding delinquent balance, all court costs and reasonable attorney's fees incurred in preparation of this matter for litigation.

### **Sellers Agent Fee**

All Stars Arabians receives a 20% commission on the sale price of any horse sold All Stars Arabians, payable at the time of the sale. All Stars Arabians will receive a 20% commission from any horse sold 90 days after the horse leaves the care of All Stars Arabians if All Stars Arabians institutes the sale, or if the horse was viewed at All Stars Arabians or in the arena with All Stars Arabians trainers. All Stars Arabians will receive a minimum of 10% commission payable at the time of sale, of any horse in its care, regardless of who is the agent for the sale. This 10% commission applies to all outside agents purchasing horses in training with All Stars Arabians.

### **Other**

Interest at the rate of 1.5% per month will be charged on unpaid balances as of the 11<sup>th</sup> of the month following receipt of billing. Additionally, any late accounts will be penalized with a \$10.00 late charge.
